NOTE: Southland District Council is bringing in new fees and discounts for dog registration in 2017. For non-working dogs, the fee is \$90 however there are discounts:

1. The dog is spayed or neutered (\$10 discount)
2. The dog is in a fenced or controlled property (\$20 discount)
3. Responsible ownership and microchipping (\$30 discount)

Please highlight on the form which discount will be relevant to your dog by putting 1, 2, 3 or all of these, if applicable, on the front page of the form in the discount section. This will help us update our records ready for next year’s fee changes. If your dog meets all three discounts, next year’s registration fee will be \$30.
