### Purpose of the Sport NZ Rural Travel Fund

The Rural Travel Fund is designed to assist with transport expenses associated with participating in regular local competitions. Sports clubs and school based clubs with young people aged between 5-19 years are eligible to apply.

- Please note that funding is not provided retrospectively.
- This is a subsidy-based funding scheme. This means that groups must contribute towards the costs of their project.

(All clubs, community-based or school-based, may apply.)

- **Individuals are not eligible to apply.**
- **Applications for assistance to attend regional or national events are not eligible.**

***Total fund available for distribution each year is \$13,000.***
